1. **Employer / Project Executing Agency:** Local Government Engineering Department (LGED), Local Government Division, Ministry of Local Government, Rural Development and Co-operatives.
2. Local Government Engineering Department (LGED) is seeking the support of a qualified international Consulting firm to provide consulting services towards supporting the implementation of the Climate Resilient Infrastructure Mainstreaming (CRIM) project
3. **Sectors to be supported:** Rural and Urban climate resilient infrastructure
4. **Project measures/Objective:** The purpose of the Project is to integrate climate change adaptation systematically into decision-making for infrastructure planning, supervision and maintenance of the Local Government Engineering Department (LGED). This is to contribute to increased resilience and enhanced livelihoods of the most vulnerable people, communities and regions in Bangladesh.
5. **Project scope:** The Project concerns the establishment of a Climate Resilient Local Infrastructure Centre (CReLIC), a center of excellence, within LGED of Bangladesh and the implementation of pilot climate resilient rural and urban infrastructure. The pilot rural infrastructure will include multi-purpose cyclone shelters (new constructions, as well as rehabilitation of existing shelters) and connecting roads in the coastal districts of Bhola, Barguna and Satkhira. The pilot urban infrastructure will include climate resilient urban roads, urban drainage network, urban water supply, urban sanitation as well as climate resilient slum improvements in the city of Satkhira.
6. **Source of funding:** The financing for the above stated Consulting Services is provided by the Green Climate Fund (GCF), KfW on behalf of the German Government as well as by the Government of the People's Republic of Bangladesh
7. **Scope of consulting services:**

The Consultant shall provide Consulting Services for:

- a) Design, Management and Supervision (DMS) support for the implementation of the pilot climate resilient rural and urban infrastructure.
- b) Environmental and Social Assessment with international development financing guidelines
- c) Effective project management and quality assurance
- d) Support to Governance improvement and Capacity Development / Training

8. Pre-Qualification process:
