The MAEFP invites international independent and qualified consulting companies, with experience in the implementation of projects of the international financial cooperation in the area of decentralization, urban development and municipal infrastructure. The formation of Joint Ventures between international and national consulting companies is permitted.

Experience in planning, tendering, implementing and supervision of works for economic, social and administrative infrastructure and working experience in the region are necessary.

Condition for eligibility is an average annual turnover in the last 3 years of a minimum of 2.0 million EUR.

DESCRIPTION OF THE PROGRAM:

PRODIA provides financing for municipal infrastructure investments and related capacity building measures in 15 municipalities in the provinces of Inhambane, Sofala and Manica. PRODIA I started in January 2014 with six municipalities (Catandica, Chimoio, Gondola, Inhambane, Massinga and

Vilankulo) and the first infrastructure measures are being constructed now. PRODIA II started in October 2015 with nine municipalities (Beira, Dondo, Gorongosa, Manica, Marromeu, Maxixe, Nhamatanda, Quissico and Sussundenga) and detailed designs for the infrastructure measures are currently being prepared by local consulting firms. The contract for the current consulting services for PRODIA terminates in December 2019 and has to be newly tendered, which is subject of this publication.

MAEFP/DNDA is the Project Executing Agency (PEA) and is responsible for the overall coordination of the Program and for its technical, administrative and financial management. For this purpose, within the DNDA, a Program Implementation Unit (PIU) has been established.

THE CONSULTING SERVICES TO BE RENDERED COMPRISE:

The objective of the Consulting services is to provide assistance in management, coordination and implementation for PRODIA I and II, including assistance to the PIU in Maputo and to the 15 Municipalities in Inhambane, Sofala and Manica Province:

- Overall project coordination and management.
- Capacity building of the municipalities to plan and implement the works by "training on the job".
- Capacity development to operate the infrastructure projects.
- Financial Management of the Program.
- Program monitoring and the reporting.
