#### I. CONSISTENCY OF BUSINESS PLAN WITH COUNTRY PARTNERSHIP STRATEGY

- 1. The country operations business plan (COBP), 2019–2021 is consistent with the strategic priorities of the country partnership strategy (CPS), 2017–2020 of the Asian Development Bank (ADB) for Mongolia.¹ In line with the Government Action Plan, 2016–2020 and ADB Strategy 2030, the overarching goal of the CPS is to help Mongolia sustain inclusive growth in a period of economic difficulty.² The COBP is aligned with the three strategic pillars set out in the CPS: (i) promoting economic and social stability, (ii) developing infrastructure for economic diversification, and (iii) strengthening environmental sustainability. The COBP will support the cross-cutting themes set out in the CPS—public sector management and gender equity. The COBP also recognizes strengthening of portfolio performance as a priority. The COBP, 2019–2021 is the third COBP under the CPS, 2017–2020.³
- 2. The COBP continues to be guided by the country knowledge plan presented in the CPS. ADB's knowledge operations will focus primarily on issues that relate to the three strategic pillars, as well as the cross-cutting themes of public sector management and gender equity. The multidimensional nature of ADB's strategic focus provides a rich context in which to deepen knowledge cooperation within Mongolia.

#### II. INDICATIVE RESOURCE PARAMETERS

- 3. Mongolia, a group B developing member country, is eligible for concessional ordinary capital resources lending (COL) and regular ordinary capital resources (OCR) lending. The indicative resources available during 2019–2021 for sovereign operations amount to \$1,132.28 million, comprising \$171.28 million for COL and \$961.00 million for regular OCR lending.<sup>4</sup> The final allocation will depend on available resources and the outcome of the country performance assessments. Cofinancing plans include an indicative additional allocation of \$40 million for COL from regional integration resources and funding for anti-money laundering and combatting the financing of terrorism, and anticorruption will be explored.
- 4. The COBP, 2019–2021 includes a firm lending pipeline for Mongolia amounting to \$944.00 million, comprising \$174.00 million to be funded by COL and \$770.00 million from OCR.<sup>5</sup> This covers 20 lending projects. During the COBP period, ADB expects to deliver technical assistance (TA) worth \$26.2 million, and administer cofinanced grants worth \$12.0 million. Areas of intervention and the resource allocation for each sector are included in Appendix 1.
- 5. The lending allocations (Appendix 2) reflect the Government of Mongolia's priorities and areas of ADB comparative advantage to achieve results in the following key sectors: (i) agriculture, natural resources, and rural development (24.1% of the 3-year program); (ii) transport (18.9%); (iii) water and other urban infrastructure and services (14.1%); (iv) finance (10.6%); (v)

energy (9.5%); (vi) health (8.5%); (vii) industry and trade (6.3%); (viii) public sector management (4.8%); and (ix) education (3.2%).

6. The TA program for 2019–2021 (Appendix 2) will enhance the design, preparation, and readiness of the lending program and will support knowledge creation, management, and sharing in Mongolia. The TA program has a strong thematic focus, in line with the lending program and in response to government priorities on agriculture, natural resources, and rural development (29.4% of the 3-year program); public sector management (21.4%); water and other urban infrastructure and services (11.4%); education (9.5%); health (9.0%); energy (6.7%); transport (6.7%); industry and trade (4.4%) and the financial sector (1.5%). Appendix 3 presents the lending and non-lending assistance program for 2018 and appendix 4 summarizes the planned knowledge program and events.

#### III. SUMMARY OF CHANGES TO LENDING AND NONLENDING PROGRAMS

- 7. The adjustments to the lending program for 2019–2021 include the following:
  - (i) **Pipeline for 2019.** The main changes are the inclusion of the Sustainable Tourism Development project originally planned for 2018; the inclusion of the second tranche of the Urban Transport Development Investment Program originally on standby for 2019; the movement of the *Aimag* and *Soum* Centers Regional Development Investment Program to stand-by 2019 and firm 2020; and the change in the focus area of the policy-based loan planned for 2019 to Ulaanbaatar Air Quality Improvement Program Phase 2. The Education for Children with Disabilities grant was also moved to 2020 from 2019.
  - (ii) **Pipeline for 2020.** The main changes include the reduction in the number of loans from nine to four because (a) the Urban Transport Development Investment Program was moved to firm 2019; (b) two operations (Research University Sector Development Program<sup>6</sup> and the Improving Fiscal Management Program) have been moved to standby 2020; (c) the Disaster Risk Management Project, Climate-Resilient Livestock Sector Development Project, and Sustainable Tourism Development Project Phase 2 have been moved to 2021; (d) after a request from the government to convert to a loan, the Upgrading Emergency Care Systems grant has been integrated into the Improving Access to Health Services for Disadvantaged Groups loan planned for 2019; and (e) the Pro-Poor Rural Energy in Rural Remote Areas grant was moved to 2021 and the Education for Children with Disabilities grant to 2020. The *Aimag* and *Soum* Centers Regional Development Investment Program is now included in the 2020 pipeline.
- (iii) **Pipeline for 2021.** The 2021 pipeline includes 10 loans and two grants. This includes the loans originally planned for 2020 as described in points (c) and (e) under bullet (ii) above. It also includes one operation on green financing that was originally included as standby in 2019. It includes five new operations covering regional road development, public—private partnerships, small and medium-sized enterprises, renewable energy, and environmental monitoring. Three loans are on standby for 2021.
- 8. Changes to the nonlending pipeline from the COBP, 2018–2020 resulted from 21 new TA projects for 2019–2021 that focus on renewable energy, public–private partnerships, gender, audit, extractive sector governance, macroprudential policy, small and medium-sized enterprises development, noncommunicable diseases, public utility services organizations, teacher professional development, and enhancing competition.
