I. CONSISTENCY OF BUSINESS PLAN WITH COUNTRY PARTNERSHIP STRATEGY

1. Economic growth in Maldives increased from 6.9% in 2017 to an estimated 7.6% in 2018.¹ Expansion in tourism, construction activities, and supporting services contributed to this growth. Tourist arrivals increased in 2018 despite a decline in tourists from the People's Republic of China, Maldives' largest tourism source market; the increase is attributed to new flights, and increased frequency of flights from Europe. Construction has also contributed to growth, fueled by the government's Public Sector Investment Program and private sector-led developments. Growth in 2019 and 2020 is expected to remain robust, averaging 6.4% on account of projected steady tourist arrivals and continued public investments, which will expand at a slower rate.

2. Following the 23 September 2018 presidential election in Maldives, a new administration was set up under a coalition of four political parties. The new government is focused on providing basic needs—such as affordable housing, clean water, and adequate sewerage—as one of its top priorities. The government pledged to provide these services in all inhabited islands by the end of its 5-year term. Decentralization is also a key priority; local councils will be empowered, and substantial changes will be made to reduce congestion in Malé and make it more livable. However, development of the Greater Malé Area will continue to be given high priority as the government plans to relocate the main port to Gulhifalhu and construct new housing projects. The government requested Asian Development Bank (ADB) assistance to formulate a new 5-year national development plan.

3. ADB's country operations business plan, 2020–2022 for Maldives and the indicative pipeline of priority projects were prepared based on consultations with various government agencies. The country assistance results areas (Appendix 1) are consistent with the draft national development plan, which is expected to be finalized in 2019.

II. INDICATIVE RESOURCE PARAMETERS

4. Maldives, a group A developing member country, is eligible for Asian Development Fund (ADF) grants and concessional ordinary capital resources lending (COL). The indicative ADF grant and COL resource allocation for commitment for 2020–2022 is \$81.19 million, which includes an \$18.86 million allocation for disaster risk reduction. The final allocation will depend on available resources and the outcome of the country performance assessments. Cofinancing and funding from other sources, including the regional pool under concessional resources, will be explored. The 2019 debt distress classification assessed Maldives to be at high risk of debt distress.² Following the ADF grants framework, the country is to receive 50% of its country allocation in grants in 2019.³

5. The lending and nonlending programs for 2020–2022 (Appendix 3) will support development outcomes in the energy and water and other urban infrastructure and services sectors. The total lending program for 2020–2022 is \$119.58 million, while the nonlending program totals \$1.50 million. The final amount of lending program is subject to resource availability and project readiness. The assistance program for both lending and nonlending products for the current year is in Appendix 4. Appendix 5 provides the list of indicative knowledge publications and events for 2019 and 2020, which seek to respond to the country's priority knowledge needs.

6. The pursuit of private sector investments and nonsovereign operations in Maldives is hampered by the following constraints: (i) lack of effective convertibility of the rufiyaa, (ii) generally weak judicial processes and enforcement of contracts, (iii) lack of a skilled workforce, and (iv) lack of an effective capital market. ADB will continue to explore potential private sector operations to support capacity building; promote the expansion of tourism and emerging export industries, and investment on sustainable energy development; and seek opportunities for public–private partnerships, including potential involvement of the private sector in public service provision.

III. SUMMARY OF CHANGES TO LENDING AND NONLENDING PROGRAMS

A. Lending Program

7. In 2020, additional financing of \$10.0 million (\$5.0 million ADF grant and \$5.0 million COL) will be provided to support the implementation of Preparing Outer Islands for Sustainable Energy Development Project.

8. The Greater Malé Waste-to-Energy Project is scheduled as a firm project in 2020. The total allocation for this project has increased from \$26.84 million to \$60.12 million following an increase in the country allocation. The project will establish a regional solid waste management facility, including an advanced waste-to-energy treatment plant, which will avert marine debris and the flow of highly polluting leachate into the ocean; reduce greenhouse gases; and reduce demand for fossil fuels used for energy generation.

9. The Greater Malé Energy Sector Project (formerly Greater Malé Infrastructure Project) is rescheduled as standby for 2021 and as firm for 2022. The total allocation for this project has changed from \$14.42 million to \$49.46 million as a result of an increase in the country allocation for 2021 and additional allocation for 2022. The project will install liquefied natural gas base power generation facilities, which will increase electricity availability in atolls using a clean, environmentally friendly fuel source.

B. Nonlending Program

10. Supplementary financing for the implementation of the knowledge and support technical assistance (TA) on Capacity Building for Country Programming and Portfolio Management has increased from \$300,000 to \$500,000 and is now scheduled for 2019 instead of 2020.

11. A transaction TA project to support the implementation of the Greater Malé Waste-to-Energy Project for \$500,000 is in the pipeline for 2020. There are two transaction TA projects to support the Greater Malé Energy Sector Project: (i) Greater Malé Liquefied Natural Gas Feasibility Study Project for \$500,000 in 2020; and (ii) Capacity Building Support for Liquefied Natural Gas Implementation for \$500,000 in 2022.
