## I. CONSISTENCY OF BUSINESS PLAN WITH COUNTRY PARTNERSHIP STRATEGY

1. **Country partnership strategy.** The country operations business plan (COBP), 2020–2022 of the Asian Development Bank (ADB) for Papua New Guinea is consistent with ADB’s country partnership strategy (CPS), 2016–2020 and the Government of Papua New Guinea’s national development plans.<sup>1</sup> The COBP is also consistent with the priorities set out in ADB’s Strategy 2030.<sup>2</sup> This COBP focuses on the five priority areas of the CPS: (i) transport, (ii) energy, (iii) health, (iv) water and other urban infrastructure and services, and (v) public sector management.<sup>3</sup> This COBP also includes education and finance. The country assistance results areas are in Appendix 1 and the list of linked documents is in Appendix 2.

2. **Economic, social, and political developments.** A new Prime Minister, James Marape, assumed office on 30 May 2019. The Government of Papua New Guinea released its Medium Term Development Plan III in November 2018, which covers 2018–2022. The Medium Term Development Plan III focuses on enabling economic growth through ongoing structural reforms and expanding the country’s infrastructure base. A large earthquake in February 2018 lowered economic growth, because of lost extractive industry production, and ADB amended the estimate for 2018 to 0.2%, but the impact was somewhat mitigated by (i) higher commodity prices, (ii) activities associated with planning and convening the Asia–Pacific Economic Cooperation summit in Port Moresby in November 2018, and (iii) reconstruction in the earthquake-affected zone. In 2019, with a full year of extractive industry production, economic growth is projected to rebound to 3.7% or more. The historic and current challenge for Papua New Guinea is to find a potential future growth path that is more inclusive, diversified, and less dependent on global commodity prices.

3. **Portfolio performance.** Project implementation performance remains satisfactory. In 2018, ADB disbursed \$267.9 million and awarded \$514.9 million in contracts. All ADB-financed projects in 2018 are expected to be audit-compliant. Counterpart agencies require ongoing capacity-building support to maintain implementation momentum and to address issues identified in ADB’s Papua New Guinea country portfolio review missions, including delays in procurement and safeguards compliance. ADB continues to provide technical support and resources to the government’s national procurement reform initiative and continuing improvements in financial management.

## II. INDICATIVE RESOURCE PARAMETERS

4. Papua New Guinea, a group B developing member country, is eligible for regular ordinary capital resources (OCR) lending and concessional OCR lending (COL).<sup>4</sup> The indicative resources available for commitment during 2020–2022 for sovereign operations total \$1,173.4 million, comprising \$1,020.0 million for regular OCR lending and \$153.4 million for COL. The final allocation will depend on available resources and the outcome of the country performance assessments. Cofinancing and funding from other sources, including the regional pool under concessional resources, will be explored.

5. Appendix 3 lists the indicative lending and nonlending program for 2020–2022. The proposed lending program for 2020–2022 totals \$1,552.5 million, comprising \$1,343.0 million in regular OCR and \$209.5 million in COL. All projects in excess of resources available will be taken up for ADB financing when additional lending resources become available. The assistance program for the current year is in Appendix 4 and the indicative knowledge publications and events are in Appendix 5.

6. The country cost-sharing ceiling ratio for the loan portfolio, as defined in the CPS, 2016–2020, was 85%. However, in 2016, ADB revised the ceiling to 90% to support the Government of Papua New Guinea’s fiscal consolidation strategy. Project-specific considerations and available financing, including cofinancing, will determine actual shares for specific ADB projects.

### III. SUMMARY OF CHANGES TO LENDING AND NONLENDING PROGRAMS

7. **Urban Water Supply and Sanitation Project.** The project is expected to be approved in 2019, but because it will not be signed until early 2020, ADB reflected the project under the 2020 lending pipeline. The project will increase access to improved water and sanitation services in provincial towns (Kerema and Vanimo).

8. **Power Sector Development Project.** The lending modality, which was proposed as a multitranche financing facility, is now expected to be structured as a stand-alone project, for a reduced amount of \$265 million, although final details are yet to be confirmed. The project supports improving transmission and distribution efficiencies and expanding electrification to peri-urban areas.

9. **Microfinance Expansion Project (Phase 2).** A \$30 million loan to the finance sector is expected to build upon the existing microfinance program, but with greater emphasis on supporting micro, small, and medium-sized enterprises, particularly those in agriculture and export-oriented industries. Technical assistance (TA) is exploring the project design.

10. **Improved Technical and Vocational Education and Training for Employment Project.** A technical and vocational education and training project, estimated at \$50 million, previously identified under the 2021 pipeline as the Education and Skills Project, was moved forward and is now shown as 2020 standby and/or 2021 firm. The project will focus on developing industry-based cluster approaches to strengthen post-secondary technical and vocational education and training institutions that will increase the ability of Papua New Guinea nationals to meet labor demand in priority sector areas, such as construction and agriculture. Proposed TA will define and refine the project scope.

11. **Land and Maritime Transport and Trade Corridor Program.** This multitranche financing facility is proposed to rehabilitate and extend one of the country’s priority highways and is expected to include a ports component. A feasibility study, funded by a \$2.5 million TA package, will determine these intermodal details. Tranche 1 is scheduled for 2021 firm (previously 2021 standby). The overall facility size (including cofinancing and government counterpart funding) is estimated at \$1.2 billion. The program will be prepared under the **Transport Project Preparatory Facility**, which is a project readiness facility of \$31 million added to the 2019 pipeline.

12. **Highlands Region Road Improvement Investment Program (Phase 2) (Tranche 1).** This is a new multitranche financing facility that will build on the Highlands Region Road Improvement Investment Program (Phase 1). The program is expected to be prepared under the **Transport Project Preparatory Facility**.
