
The German Healthcare Market


Demographic Change

Care Recipients in Germany


Number of care recipients in Germany 2011 – 2019 (in thousands)






The German Medical Aids Market

- Balancing an existing disability of an individual



Market volume of medical aids in Germany 2008 – 2018 (in EUR billion)




